Donate Family Lounge in the Neonatal Intensive Care Unit at TMH

Ronald McDonald House Charities of Tallahassee and Ronald McDonald House Charities Global have donated funding for a Family Lounge in the Neonatal Intensive Care Unit at the Tallahassee Memorial Women's Pavilion. According to Kathy Anderson, Executive Director and President of Ronald McDonald House Charities of Tallahassee, "At Ronald McDonald House Charities of Tallahassee, it is our mission to create, fund and support programs that directly improve the health and well being of children. We are pleased to provide this funding for the Family Lounge in the NICU at Tallahassee Memorial."

Three existing rooms in the Tallahassee Memorial Women's Pavilion, with a combined 495 square feet and located immediately outside the doors to the Level II NICU and Level III NICU, were renovated to house the Family Lounge. The first room is the Patient (Family) Education Center with educational materials and resources. The second room is the Refreshment Center with an under-counter refrigerator, microwave, ice machine, sink, table, chairs and telephone. Both the first and second rooms open onto the NICU hall. The third room is the Quiet Room that can be accessed only through the Refreshment Center. It will have soft lighting, a couch, chair, lamp, art work and a television. All rooms have complimentary Wi-Fi internet access for guests. This is consistent with the rest of the TMH campus.

TMH offers the only Level III (highest designation) NICU in a 20-county area of North Florida and South Georgia. More than 650 infants annually are admitted to the NICU and their stays can range from one day to weeks. Kathy Waleko, R.N., Ph.D. who serves as the Administrator of Women's and Children's Services at Tallahassee Memorial said, "The Family Lounge will be open 24 hours a day, 365 days a year and will provide a wonderful environment for parents and families to have a cup of coffee, watch television and relax in a quiet space."

"The renovation project was completed in August and the date for the dedication ceremony will be announced in the fall," said Paula Fortunas, President and CEO of the TMH Foundation. "TMH is exceedingly grateful for this Lounge that will serve both the physical and emotional needs of parents and families of critically ill babies and it is on their behalf that we applaud and recognize the local and global Ronald McDonald House Charities and the other major contributors — Ingram Enterprises and Carpet Studio."

Gary Stout, President and Owner of Ingram Enterprises, said, "We are very proud to support TMH by contributing toward the Family Lounge which is a comfortable, relaxing area for parents and families of the NICU patients." Both Gary Stout and his wife Joan Stout, who serves on the Board of Directors of Ronald McDonald House Charities of Tallahassee, are long-time supporters of TMH. Carpet Studio Sales Manager Charles Maphis added, "It is a pleasure for Carpet Studio to participate in this important addition to the NICU at TMH where it will benefit so many families."





Nursing Resource Center in her honor. Mrs. Futch commenced her work at TMH

as a staff nurse in 1969. As a result of her outstanding performance in a variety of nursing roles, she was named Senior Vice President for Nursing Administration and Chief Nursing Officer in 1986 and held that position until her retirement in 2001. Both Robert Daniel, who initially hired her at TMH, and M. T. Mustian, who recognized her great capacity for leadership and elevated her to the hospital's top nursing position, were present to salute Mrs. Futch.

In delivering the Joan R. Futch Nursing Resource Center's dedicatory address, Tallahassee Memorial's current Vice President and Chief Nursing Officer Barbara Gill MacArthur said:

"Joan created a foundation for nursing at TMH and her legacy is far-

reaching, so it is appropriate that this space is being dedicated in her honor. The Joan R. Futch Nursing Resource Center will provide an environment in which nurses can study, have access to current publications and research findings and consult with



In 2006, at the age of 36, Sarah Nan learned that she had thyroid cancer. A year later, she was diagnosed with one in-situ ductal carcinoma and two invasive ductal carcinomas. "That's when my whole world changed," Sarah Nan said. She underwent a double mastectomy and radiation treatments at Tallahassee Memorial. Now, she is doing well and actively advocates for women with cancer through initiatives such as Cards for a Cure.

The Results: How Loved Ones Really Feel About Sharing Their Inheritance

72%: A gift to charity is a reasonable choice. 17%: Not sure. 11%: Wish 100% would go to family members.

As the study indicates, the majority of individuals agree that charitable bequests are important.
